Recognition of 40 years + Volunteer Service to PSCU

These scholarships are in dedication of **John E. Breen, Jonathan D. Gallimore, Bernard Hanus, Carol Palazzolo, Nora Sharpley, and Frederick F. Morgan** who has served as volunteers of PSCU in various roles for at least 40 years. These (6) \$1,000 scholarships will be available to all members in good standing, who wish to continue their education at a college level.

Board of Directors Educational Scholarships

In recognition of the commitment to financial education for members of all ages, the PSCU Board of Directors has committed up to (4) additional scholarships for any member in good standing who wish to continue their education at the college level. Public Service Credit Union employees elected or appointed officials of this credit union, and their immediate family are ineligible to apply.

Eligibility for all scholarships

1. Scholarships are available for college or technical school.
2. The applicant must be a member of Public Service Credit Union. The applicants account must be in good standing.
3. The applicant cannot have received a PSCU scholarship in the past two years.
4. Public Service Credit Union employees elected or appointed officials of this Credit Union, and their immediate families are ineligible to apply. Immediate family is defined as parents, spouses, siblings and children.

The scholarship recipients agree to have their pictures and names featured in the PSCU's newsletter, PSCU advertising, and media press releases.

Requirements

1. Must meet all eligibility requirements.
2. All applicants are required to submit 2 letters of recommendation from a teacher, guidance counselor, employer or community leader.
3. Applicants must have a minimum cumulative GPA of 2.5.
4. Applicants are required to submit a 60-second video summarizing why it is important to be financially responsible. This video **must be** a minimum of 60 seconds and maximum of 3 minutes.
5. Applicants must submit their most recent transcript to support GPA, (photocopy of transcript accepted).
6. The application, video, and **all** supporting documentation must be received online or by mail to Public Service Credit Union no later than close of business on April 30, 2024.

7. Applicants must be accepted to a college or technical school before scholarship funds are disbursed and payments will generally be made to the college or technical school.
8. Incomplete submissions will be disqualified.

Factors Considered

1. Grade point average
2. 60 second video
3. Letters of Recommendation
4. Community Involvement/Charitable Works
5. Extracurricular involvement in school

Selection and Judges

All applications will be verified for accuracy. Scholarship recipients will be chosen based on the information submitted and without regard to income, race, religion, national origin, sex, handicap, or familial status. Factors considered will be judged as a whole, leading to the choices of well-rounded individuals.

Judges' decisions will be final. Judges' choices will be made known to the recipients no later than the last Friday in May.
